

This is the Application for a tuition scholarship to the Wayne State University Law School. The scholarship is intended for those that attended Wayne State University for at least part of their undergraduate degree.

NOTE: *Before submitting this scholarship, please send an email to the scholarship committee at: CarlZiemba@gmail.com. The email should briefly express your intentions in public service. It is important to note that scholarship recipients have a demonstrated commitment to public service*

Ziemba Scholars –are academically able students of the Wayne State University Law School that also attended Wayne State University for undergraduate school. The Ziemba scholars recognize a need for all lawyers to contribute to society’s underserved population.

The scholarship fund—called ZiembaScholars.org—was bequeathed with 3.1 million dollars in 2007 immediately upon the death of advocate Carl Ziemba. Mr. Ziemba, a law school graduate of Wayne State University and the Wayne State University Law School (class of 1948) left his entire estate to create a fund that encouraged a career that included charitable works. Applicants for this scholarship should consider this notion prior to applying.

Eligibility and Selection Criteria

Up to 15 scholarships can be awarded annually, but quite often fewer than five scholarships are provided. The scholarship is open to first year, second year and third year law students. Most scholarship recipients have all their tuition paid for the year the scholarship is awarded. Sometimes half or partial tuition scholarships are awarded.

The selection of recipients is based on academic achievement, demonstrated leadership potential, personal need, participation in community service, and future commitments to community service.

Application Deadline

This is a competitive application process. Applicants must first send an email to the selection committee. This document contains the more detailed application and should be printed out, completed and mailed to the committee. The application should be sent via US Mail (or courier service) along with any supplemental items requested.

Supplements to add to your Application

- 1) A current academic transcript;
- 2) A current resume;
- 3) A typed essay (750 words or less) describing the applicant’s background, including any advantages he or she has had, and/or any obstacles or hardships the applicant was forced to endure.
